## INSTRUCTIONS FOR PREPARING AND FILING REGISTRATION FORM OF CHARITABLE TRUST

### WHO MUST FILE

Pursuant to Sec. 12581 of the Gov. Code and Sec. 300 of the Calif. Adm. Code, Title 11, all Trustees holding property for charitable purposes in the State of California must register with the Registrar of Charitable Trusts except those parties exempt by Sec. 12583 of the Government Code.

### WHEN TO FILE

Pursuant to Sec. 12585 of the Gov. Code and Sec. 300, Calif. Adm. Code, Title 11, every Trustee subject to the Uniform Supervision of Trustees for Charitable Purposes Act shall file with the Attorney General within six months after any part of the income or principal is authorized or required to be applied to charitable purposes.

### NAMES AND ADDRESSES OF TRUSTEES OR CORPORATE OFFICERS (Item 3)

In the case of a testamentary or inter vivos trust, please submit the names and addresses of all individual and corporate trustees.

In the case of a Charitable Corporation or corporation created for the administration of a Charitable Trust, please submit names, titles, and addresses of all corporate directors and officers.

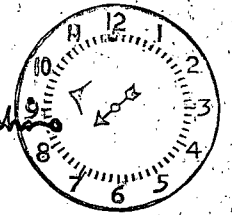

Resolution of the ~~City Council~~ <sup>Board of Supervisors County</sup> of the ~~City~~ <sup>San Bernardino</sup> of ~~San Bernardino~~  
Regarding the Establishment and Support of a Cultural  
Center in Western San Bernardino County

WHEREAS, there presently exists a need for the establishment of a cultural center to be located in Western San Bernardino County, which center would provide physical facilities and buildings encompassing a museum, historical landmark, art gallery, amphitheater and multi-purpose meeting and recreation hall for the use, education and benefit of all interested persons, and

WHEREAS, it is recognized that such facilities would present a broad cultural and recreational program for the enjoyment, edification and benefit of all citizens and communities of Western San Bernardino County, including the cities of Upland, Montclair, Ontario, Chino and the County of San Bernardino, and

WHEREAS, the City of Upland has presently donated the use of a five-acre parcel of land on 18th Street, in said City, for the establishment of said center, and

WHEREAS, the Chaffey Communities Cultural Center, a private, non-profit corporation, has been formed to establish said center and has raised a substantial sum of money by private donations for that purpose.

NOW THEREFORE, the ~~Council~~ <sup>Board of Supervisors County</sup> of the ~~City~~ <sup>San Bernardino</sup> does hereby resolve as follows:

1. That it recognizes that the establishment of such a cultural center would benefit the whole of Western San Bernardino County, including the ~~city~~ <sup>area</sup> and citizens of ~~the County of San Bernardino~~ California.
2. That it approves in principal the establishment and maintenance of such a center, supported in part by public funds, providing all the various agencies above mentioned can agree on an equitable basis of contributions to their mutual satisfaction.
3. That it agrees to appoint at least two persons to represent this ~~city~~ <sup>County</sup> to serve on a joint-powers study group representing all of said interests for the purpose of investigating and reporting on the practical and legal aspects of such a joint undertaking.
